PRESIDENT'S REPORT:

President Ben Kaufman, the aging of our community is 50 years old, yet it's extremely well maintained. Our Community Manager is on top of so many different things, but there are items that are going to require more maintenance in the coming months and years. On addition to the reserve study regarding the faults under the road and that's something we need to repair and replace. Which requires some patience and support from our community. COMMUNITY MANAGER'S REPORT:

Community Manager Christine Baldanza, our underground pumps on Lakeshore were pulled in July we are in line to get them repaired and have been evaluated. One needs a motor and the other one a shaft stamped on it from something that had gotten inside, and they both needed a major amount of work. They are going to be back within the next three weeks. Prior to that, we have a wall that is holding electrical boxes that hold the electricity to those pumps. Over the last few months, I have noticed that the wall has started to move a little. When the company was out here, they evaluated electrical boxes. They are exactly 13 years old they have a life of 10 years, so they are going to be replaced. The wall that they are going to on will be replaced with a new wall. That wall is 15 years old, and the ground has moved a lot in that area. After the new wall is built then put the new boxes on and then they're going to put in the pumps. It should be done in the next month. The front entrance has an orange netting to show that it is under construction. We are waiting for the sign from the city and there are some things that we have had to change to get to where we are now. Many trees have been removed during the summer because of the intense heat. The tree guy has examined more trees and have looked at multiple trees to see which ones need to go. Ryan Kidner added extra water to all our trees, and we were able to save some of the trees but some of them were not. Dead trees have become a safety issue and can cause a financial burden down the road. We will be planting new trees this year. We will be treating the Lake again this week because of the weed growth. We have not had any golden algae and the fish have all survived.
